UNFINISHED BUSINESS

County Water Quality Management Plan- (Graham) Part of the Cross Acceptance Plan. Hearing at County Administration Building for public comment March 26, 2025. (Conley)) All parties (Pinelands) State, County and Borough come together to decide the best course of action for Master Plans for all entities.

Open Space Eco-Park- Jake's Law Playground (Graham) Contract awarded and work started. Pause in construction to get updated pricing for and delivery of centerpiece. (Verna) Will hear back from contractor on latest pricing and will revisit the project cost.

Mobile Carrier Projects at Water Tower

(1) Dish Network- No change. Project still on hold.

(2) Verizon Wireless Lease (Graham) Verizon is finalizing construction plans.

USDA Projects

- (1) Water Project- Phase 1B- (Verna) Plans submitted plans to USDA. Making adjustments for signed and sealed copies that will be sent to USDA in a week. Project for dehumidification and epoxy coating. This will exhaust the final funding on the grant.

Adams Avenue/Franklin Streetscape Project- (Verna) Requested contractor schedule for line striping and reseeding.

Clay Street/Madison Avenue Project- (Verna) Contractor submitting post construction submittals and measurement. Closeout documents being drawn up.

Madison Avenue Bet. Webster St & DeHirsch Ave- (Verna) Bid opening set for April 9, 2026. Answering comments on the drawing. (Graham) Requesting an extension of time on 2023 funding in the event there is an issue.

NJDOT LTPF: Railroad Trestle Bridge Project- (Graham) Waiting on DOT approval to execute contracts.

DOT Sumner Avenue Bikeway- (Verna) In closeout phase. Looking for final payment voucher.

DOT Pavement Preservation Pilot Program-(Verna) In closeout phase with DOT. Material certifications from contractor received. Processing final change order.

Borough Redevelopment Zone (Zumpino) Decision to look at the entire town as a redevelopment area rather than the airport as first considered.

Zumpino- The Borough is supporting the Woodbine American Legion with an application in their attempt to obtain funding from Congressionally Directed Spending.

Zumpino- The New Jersey EDA is offering funding for cannabis businesses through the borough. The program is called C-Pace. The new cannabis business that is working toward locating in the borough is asking that council consider the program. Discussion ensued.

Pikolycky- Woodbine Elementary School, Mayor Pikolycky, Councilwoman Prettyman, and Department of Education met to discuss a report done on the Woodbine, Upper Township and Dennis Township schools. Woodbine Elementary School is applying for capital projects.
